

# Erasmus+ Programme Key Action 1 Learning mobility for higher education students and staff

## Inter-institutional agreement 2023-2029

between institutions from
EU Member States and third countries associated to the Programme
and third countries not associated to the Programme

The institutions¹ named below agree to cooperate for the exchange of students and/or staff in the contex of the Erasmus+ programme. This agreement is valid for the Erasmus+ call years 2022-2029 in:

- KA131 outgoing from UR
- KA171 incoming/outgoing to/from UR

The institutions commit to sound and transparent management of funds allocated to them through Erasmusand to respect the quality requirements of the Programme, outlined in the Erasmus Charter for Highe Education<sup>2</sup> and in this agreement.

The institutions agree on exchanging their mobility-related data according to the principles of GDPR<sup>3</sup> and in line with the technical standards of the European Student Card Initiative<sup>4</sup>, when this becomes available for international mobility involving third countries not associated to the Programme.

Sending institutions located in EU/EEA countries have to ensure compliance with the provisions of art. 40 GDPR for all participants' personal data exchanged in the context of their mobility with institutions from non EU/EEA countries without an adequacy decision, on the condition that enforceable data subject rights are effective legal remedies for data subjects are available in the respective third country. The participant should be informed in a transparent manner about the level of protection of their personal data, if this is different from the one where the sending institution is located.

- students the average grade, knowledge of English (at least B1), a positive opinion of a academic teacher, motivation letter etc.
- staff scientific achievements, knowledge of English (min. B2), etc.

The University of Rzeszów should receive a recruitment protocol indicating the selected candidate. Recruitment documents should be stored in the appropriate Erasmus+ office.

- Provide assistance related to obtaining visas, when required, for incoming and outgoing mobile participants, according to the requirements of the Erasmus Charter for Higher Education and, i needed, use project funds in the most inclusive way to cover related costs partially or in full.
- Provide assistance related to obtaining insurance, when required, for incoming and outgoing mobile
